# Grounds and Maintenance Report—March 2025--Liliane Benucci, Tisa Houck, Lorin Myers, Rene'e Weber, Susan & Steve Woodard, John Chant committee members

Pressure washing of the concrete sidewalks, walking bridge, one bench, all entrance signs and the condominium association brick wall that holds the 17 entrance sign was completed on February 28th. Water seal to the walking bridge was applied on March 4<sup>th</sup>.

One light repair on Concord Rd. was completed by Duke Energy.

All 4 entrance signs were repainted, completed on March 9<sup>th</sup>.

Pond one continues to pile up vegetative debris and sand at the deck and retention wall on Revere Place. There is a dangerous subsidence in the sod in front of the deck. The first catch basin is completely full and doesn't show any sign that water is flowing. The second catch basin is somewhat clearer and shows some signs that water is moving.

The weir is clogged with vegetative debris and is unmanageable. Some water is flowing down to the walking bridge but not enough to drop the pond levels noticeably.

Service was called for the fountain on pond two to remedy a diminishing volume of spray. The cause was leaves and debris. That was the first time we had that problem in pond two. We have experienced a similar problem at the pond three fountain one other time, in 20 years.
